Brief Writeup on Flow Chart:

- a. We have devised a collection mechanism to collect E-Waste across India through our Dismantler M/s. AER Worldwide India Pvt Ltd as they have an agreement with their reverse logistics partner (RCI Logistics Pvt Ltd & Professional Logistics Private Ltd) to use their warehouses as their collection centre. (List of collection centre is also attached along with the reverse logistics agreement).
- b. We intend to use the warehouses of AER's Reverse logistic partners (RCI Logistics & Professional Logistics) as E-Waste collection centre, we opt below mentioned mechanism to collect E-waste.
- We use website link to request over filling up forms, sending Email and tollfree number of us to give request for E-Waste collection.
- If client calls to our Toll Free Number or send a mail to collect the e-waste, the same will be intimated to our dismantler AER Worldwide India Private Limited.
- e. Then AER will organize pickup at doorstep of consumer or assistance will be provided to drop the e-waste at the nearest collection centre close to consumers availability.
- f. We will publicize our collection system which includes details of our collection points for making collection system effective and workable.
- g. Move the collected e-waste to the dismantlers facility through the reverse logistics partners and further the Printed Circuit Board Assemblies are sent to the recycler's facility by AER after Dismantling.

(NetApp importer and supplier of Servers used as Storage systems) from any location within India for further storage & recycling. For this purpose, Customer shall follow the following process:

- · After dismantling, AER Worldwide India Private Limited shall provide the certificate of dismantling to NetApp for their record.



Under the E-WASTE (Management) Rules, 2016, it is necessary for the E-WASTE to be properly channelized till the stage of its recycling and final disposal. Hence, it is imperative that the electrical and electronic equipment that are rendered useless on account of the end of its life or any accidental breakage or damage, is disposed of in a manner that is not detrimental to the conservation of the environment and does not cause any health hazard to any living beings. With a view to attain this objective, certain responsibilities have to be borne by all the concerned stakeholders including the producer, dealer, dismantler, recycler and also the consumer, involved in the production, use and disposal of the electronic equipment.

Please be aware that you are a responsible consumer under the E-WASTE rules. Kindly take note of the symbol below which connotes that you should not dump any of the electrical and electronic equipment including air-conditioners in garbage bins, neither should you dispose of the same through any scrap dealers.

Negative consequences of improper disposal of E-WASTE product:

- Oil & Gases which is present is some of E-WASTE like compressor and CRT causes environment pollution.
- Toxic material present in E-WASTE get mixed with earth, air, water etc and causes health issues.
